A RESOLUTION ESTABLISHING SEWER USER FEES, SOLID WASTE FEES AND AMBULANCE SERVICE FEES EFFECTIVE JULY 1, 2012

WHEREAS, Section 99.06 of the Burlington City Code provides that the Burlington City Council shall by resolution establish rates to be charged for contributors to the City's Sanitary Sewer System; and

WHEREAS, it is the desire of the City to maintain the Sewer Fund, an Enterprise Fund of the City, in sound financial condition; and

WHEREAS, it has been found that to maintain sound financial condition in the Sewer Fund required an adjustment in sewer rates.

NOW, THEREFORE, BE IT RESOLVED, that for billings rendered on or after July 1, 2012, the following sewer user charges shall be in effect:

2. In addition to the minimum annual rate, the following charges will be made when applicable:

WHEREAS, Chapter 106.06 of the Burlington City Code provides that the Burlington City Council shall by resolution establish rates to be charged for the collection of solid waste; and

WHEREAS, it is the desire of the City to maintain the Solid Waste Fund in sound financial condition; and

WHEREAS, the Des Moines County Regional Solid Waste Commission is considering increasing the tipping fee by \$2.00 per ton while the recycling fee has increased from \$3.05 to \$3.15 per month.

NOW THEREFORE, BE IT RESOLVED that for billings rendered on or after July 1, 2012, the monthly solid waste fee per residential unit shall be increased to \$12.10 from \$11.45.


WHEREAS, the City operates an emergency ambulance service; and good financial management practices dictate that charges for services be established to cover the cost of providing the service.


NOW THEREFORE, BE IT RESOLVED that effective July 1, 2012 the following fee schedule shall remain the same:
